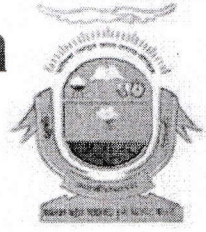

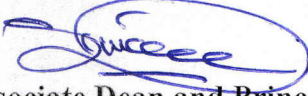
**Terms & Conditions :**

1. The appointment will be purely on temporary basis and will not be regular employment. The candidates will have not claim for his/her continuation of service as well as claim for appointment on regular establishment in the services of VNMKV, Parbhani.
2. As per Supreme Court Judgement No.MLP-55453/90 after the period (11 month) will not be regular employment will not involved any claim permanency to employment in any manner what so ever.
3. The selected candidate will have to join within 7 days after receiving the selection offer.

4. In case of resign or quite, he/she shall have to tender one month prior notice, failing which he or she should remit one month consolidated amount in lieu period notice.
5. Age limit: candidate should not be more than 38 years age on last date of submission of application. However, age relaxation will be given to SC/ST/OBC/PWD candidate as per the government rules and regulation.
