5. In case more number of applications, candidates will be shortlisted on merit basis based on academic performance/publications/experience etc. Only shortlisted candidate will be interviewed by the selection committee.
6. No TA/DA will be paid to the candidate for appearing for interview.
7. Candidate must submit relevant proofs of their age, qualifications, experience etc with the application and must produce all original documents for verification at the time of interview.
