

Actual interview will be held in the office of Director of Research, VNMKV, Parbhani (date will be notified through Email/Phone communication). For verification, the original and attested photocopies of concern documents should be produced.

Terms and Conditions:

- 1. Appointment is of purely on temporary basis and for six months and may be extended on satisfactory performance of the candidate and subject to approval by the university authority. The candidature of the selected candidate will be cancelled at any time without giving reason(s) thereof.
- 2. The selected candidate will be required to give an undertaking that he/she will not leave the assignment half way and shall complete the work in the prescribed time limit. In this

regards, the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per university rules.

- 3. The selection committee will interview only eligible candidates. The applicants will have to appear for the interview on scheduled date and time at their own cost.
- 4. If candidates are more, written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the selection committee. The candidate will be tentatively selected on the basis of both academic and extra-curricular activity performance marks (50 Marks) and selection committee interview (50 marks).
- 5. The selected candidates will have to work at the Farm Machinery Manufacturing, Training and Testing Centre, College of Agricultural Engineering and Technology, VNMKV, Parbhani Dist. Parbhani or within or outside its jurisdiction in the field/ office, as per the mandate of the project.
- 6. Selected and appointed candidates will not be allowed to accept any other appointments/ assignments during the period.
- 7. The notification does not mean that all the posts will be necessary will be filled. The discretionary power will rest with the selection committee constituted for the purpose.
- 8. The selected candidates are appointed on tenure basis and shall not have any right of claiming permanency benefit of the said post or any other posts of university by virtue of this appointment.
