

**Terms & Conditions :**

1. The candidate should not be a registered student of any university/Institute.
2. The appointment will be purely on temporary basis and will be terminated after completion of academic assignment. During the assignment if candidate fails to satisfy requirements academic assignment/work, he/she will be discontinued without any notice.
3. The selected candidate will have to join assignment within seven days from the date of issue of the order, failing which the order shall be treated as cancelled.
4. As per Supreme Court Judgment No. MLP-55453/90, after the expiry of 11 months period, the candidate will not be considered for regular employment or he/she cannot claim for permanency to employment seniority in any manner what soever.
5. In case more number of applications, candidates will be shortlisted on merit basis based on academic performance /publications /experience etc. Shortlisted candidate will be interviewed by the selection committee.
6. No TA/DA will be paid to the candidate for appearing for interview.
7. Candidate must submit relevant proofs of their age, qualifications, experience etc with the application and must produce all original documents for verification at the time of interview.

8. Selected candidate will have to work anywhere in the jurisdiction of College of Food Technology, VNMKV, Parbhani. The decision of Associate Dean and Principal will be final and binding in all respects.
9. The selected candidate has to submit the undertaking on Rs. 100 bond paper for accepting all the terms and conditions prescribed for the job. Candidate shall complete the assigned work in prescribed time and will not leave the job halfway. If he/she intends to do so he/she has to give one month advance notice in writing otherwise he/she will have to deposit the amount of one month's salary.
