### **PREAMBLE**:

The Government of Maharashtra vide it's Resolution referred to at Sr.No.1 above has sanctioned New Career Advancement Scheme (CAS) to the Academic staff members of the State Agricultural Universities in Maharashtra on the basis of terms and conditions prescribed by the UGC/ICAR. - 4. In case of suitability/eligibility of any of incumbent referred in above order, as assessed by University is not agreed to any of the authority concerned, the order inrespect of such incumbent will be treated as cancelled.
- 5. The order and date of granting next higher AGP to the incumbent by this order shall be changed/ modified as per the instructions from Government/ICAR/any other Competent Authority and/or if found that they are wrongly recorded.
- 6. The University reserves all the rights to change or modify this order if subsequently found that the award has been granted on the basis of incorrect or false information furnished by the incumbent.
