# ORDER

The Government of Maharashtra vide its Resolution referred to at Sr.No.1 above has sanctioned new Career Advancement Scheme to the Academic staff members of the State Agricultural Universities in Maharashtra on the basis of terms and conditions prescribed by the UGC/ICAR. Accordingly, the norms for granting promotions under Career Advancement Scheme are prescribed by the Government of Maharashtra vide reference no.3.

The provision of UGC regulations referred above vide reference no.2, deals in detail with the rules and regulations for Career Advancement Scheme (CAS). Also Government of Maharashtra vide letter No. Sankirna 1519/Pra.Kra94/6-a dated 20th July, 2019 has informed that, the academic staff member who has completed their refresher courses/ training on or before 31.12.2018, shall be entitled to get benefits Under Carrier Advancement Scheme (CAS) on their due date i.e of completion of service requirement

Accordingly, this University had called the proposals for upward movement of AGP under CAS. These proposals were duly evaluated by the Scrutiny Committee and verified by the Internal Quality Assurance Cell of the University. Subsequently, Selection Board / Selection Committee (as depicted in MAU Statute 2014 and UGC Regulations-2010) of the respective subject have considered the proposals of their respective disciplines and recommended the date of applicability of Higher AGP (Stage 3 to 4 AGP from Rs.8000/- to Rs.9000/-) to the eligible academic staff members (shown in Annexure-1). And also the Selection Board / Selection Committee has recommended to revise the date of award of Stage 3 to 4 of concerned eligible academic staff members as per Government Letter No.Sankirna 1519/ PraKra 94/6-A dated 20th July, 2019.

The Government of Maharashtra vide its Resolution referred to at Sr.No.5 above has sanctioned new Career Advancement Scheme to the Academic staff members of the State Agricultural Universities in Maharashtra w.e.f.12.8.2021. On before that date Career Advancement Scheme to the Academic staff members will be applicable as per the 6<sup>th</sup> pay Commission rules and regulation.

### **Terms and Conditions**

- 1. The incumbent shall not claim any benefit as of regular promoted Assistant Professor/ Associate Professor / equivalent by virtue of higher grade pay awarded by this Order.
- 2. The incumbent shall not claim seniority in the cadre by virtue of the date of award of higher grade pay.
- 3. The incumbent shall perform all the duties, in addition to his own duties, assigned to him/ her by the University authorities from time to time.
- 4. In case of suitability/eligibility of any of incumbent referred in above order, as assessed by University is not agreed to any of the authority concerned, the order inrespect of such incumbent will be treated as cancelled.
- 5. The order and date of granting next higher AGP to the incumbent by this order shall be changed/modified as per the instructions from Government/ICAR/any other Competent Authority and/or if found that they are wrongly recorded.
- 6. The University reserves all the rights to change or modify this order if subsequently found that the award has been granted on the basis of incorrect or false information furnished by the incumbent. In such case the order shall be cancelled with lump-sum recovery from the salary/pension of the incumbent.
- 7. The necessary entries in respect of pay fixation and next higher AGP awarded to the incumbent by this order shall be recorded by the respective Drawing and Disbursing Officer in the service book of the incumbent.
- 8. The amount required for payment of arrears due to grant of next higher AGP awarded by this order shall be worked out by Head of Office/Institution and shall submit it to the Comptroller, VNMKV, Parbhani for making necessary budgetary provisions. The amount of arrears will be paid to incumbent only after receipt of funds for this purpose.
- 9. The over payment, if any, made by virtue of this order will be recovered from the salary and/or pensionary benefits without any notice thereof. The Candidate shall have to execute a Self Declaration to this effect in the Proforma enclosed herewith as Annexure-3.
