A. For Supported Invention:


- a. Administrative approval of Vasantao Naik Marathwada Krishi Vidyapeeth, Parbhani.
- b. Filing of IP through IPR Cell, VNMKV, Parbhani.
- c. Procedure at Patent Office
- d. Commercialization of Innovation and Revenue Generation

B. For Incidental Invention:

- a) Administrative approval of VNMKV, Parbhani.
- b) Rights sharing agreement between Vasantao Naik Marathwada Krishi Vidyapeeth, Parbhani and Inventor

OR

- b) NOC from VNMKV, Parbhani
- c) Accordingly filing of IP.
