Research Review Committee (RRC) meetings for various Sub-committees are scheduled to be held at Parbhani on the dates given below.



General Instructions

1. The report should be prepared in research project proforma using **RPF – I** (Basic information about the project such as title of the projects, its associates, location, objectives, technical programme, observations to be undertaken, date of start, date of termination, financing approximate cost etc.) for proposed programme, **RPF – II** (Various items for obtaining reports) for ongoing programme and **RPF – III** (Final report) for completed experiments.
2. The convenors of the respective RRC will make all necessary arrangements for the meeting of their RRC.
3. As informed earlier all the presentation should be through LCD only and number of copies of report should be 30.

4. All the programmes conducted through ICAR, State schemes, adhoc projects, other agency schemes, revolving fund projects, centrally sponsored scheme product testing as well as Department / PG Research abstract should be included in the report.
5. The Convenors shall arrange for recording the proceedings of the meeting and inform the same to undersigned for approval within a week. They will also inform the list of completed experiments / projects likely to be put up in Research Finding Release Committee (RFRC) for recommendation immediately after the meeting. This will enable the undersigned to prepare Agenda for RFRC.
6. The respective Convenors will be responsible for preparation and presentation of completed experiments/projects in RFRC for final recommendation.
7. The Associate Director, NARP/Officer Incharge, ARS/Scheme will prepare annual reports for the research extension activities of their Zone/Station/Scheme and present in respective RFRC.
8. The Convenors will be responsible for submission of information to State Level co-ordinator.
9. NO TA/DA will be admissible to the invitees to outside the University for attending these meetings.
10. The concerned scientists/Convenors are requested to submit 3 copies of the final report to the Directorate of Research with a CD in MS words before scheduled date of meeting.
11. The abstracts of the research be made available to university Librarian on CD/online by respective convenors.
12. The ongoing programmes should be presented in detail.
