Terms and Conditions

1. The candidate should not be a registered student of any university/institute.
2. The incumbents shall have to join assignment within seven days from the date of issue of the order, failing which the order shall be treated as cancelled. They shall have to produce all relevant certificates in original to the concerned officer for verification at the time of interview.
3. The appointment will be purely on temporary basis only and will be terminated after completion of project under condition of satisfactory work. If he/she will be fail to satisfy the assigned work of NPHPVA of NRG project, he/she may discontinue without any notice.
4. Selected candidates will not be entitled to claim for regular appointments/absorption or otherwise against any regular post under VNMKV Parbhani or in NPHPVA of NRG, ICAR-IINRG Ranchi.
5. The selected candidate has to join under Principal Investigator, “Network Project on Harvesting, Processing and Value Addition of Natural Resins and Gums” (NPHPVA of NRG), College of Food Technology, VNMKV, Parbhani.
6. The next appointment for continuation of the post is depending upon receipt of grants from ICAR-IINRG Ranchi.
