

Terms & Conditions :

1. The applicant should not be a registered student of any University/ Institute.
2. Candidates must submit relevant proofs of their age, qualifications, experience etc. with their application and must produce original documents at the time of interview.
3. In case of more number of applications received, the applications will be shortlisted on merit basis based on academic performance / publications / experience etc.
4. Only shortlisted eligible candidates will be interviewed by the selection committee.
5. No TA/DA will be paid to the candidates appearing for the interview.
6. If selected , the candidate will have to join the assignment under **Head, Dept. of Plant Pathology, VNMKV, Parbhani** within seven days from the date of issue of the order, failing which the order shall be treated as cancelled.

7. The appointment will be purely on temporary basis and will be terminated after completion of academic assignment under conditions of satisfactory work. During the assignment, if he / she fails to satisfy requirements of academic assignment/ work, he / she will be discontinued without any notice.
8. The selected candidate has to submit an undertaking on Rs. 100/- bond paper for accepting all the terms and conditions prescribed for the job. Candidate has to complete the assigned work in prescribed time limit and will not leave the job halfway.
9. As per Hon. Supreme Court Judgement No. MLP-55453/90, after the expiry of 11 months period, the candidate will not be considered for regular employment or he/she cannot claim for permanency to employment seniority in any manner what so ever.
10. The candidates will have no claim for his / her continuation of service as well as claim for appointment on regular establishment in the services of VNMKV, Parbhani.
